In response to these questions, as well as R2020-169, the Committee on Finance is in the process of coordinating a hearing on risk management efforts. It is important to know what measures are being taken by departments, and to discuss what may be improved upon to save the City and taxpayers money. I was hoping to wait until a new Chief Risk Officer had been brought on board, but it is time we move ahead regardless.
