# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the MI-2 Limited Manufacturing / Business Park District symbols and indications as shown on Map No 5-G in the area bounded by

North Clybourn Avenue; a line from a point 214.98 feet southeast ofthe intersection of North Clybourn Avenue and North Southport Avenue as measured at the southwesterly right-of-way line of North Clybourn Avenue and perpendicular thereto; the alley next west of of North Clybourn Avenue; the alley next south of the intersection of North Clybourn Avenue and North Southport Avenue (said alley is perpendicular to North Southport Avenue) and North Southport Avenue.






