**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing al! ofthe RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 5-M in the area bounded by:**

**A line 50 feet north of and parallel to West Dickens Avenue; the public alley next east of and parallel to North Monitor Avenue; West Dickens Avenue; and North Monitor Avenue.**

**To those of an MI-1 Limited Manufacturing/Business Park District**
