**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:**

WARD	LOADING ZONES / STANDING ZONES:
1	2355 West Augusta Boulevard, Amend Ordinance by increasing footage 40 feet west, Amend Loading Zone, 7:00am-12:00am, All Days [02021-1609]
24	3159 West Fillmore Street (Southside) 30 Minute Standing Zone; from a point 20 feet East of South Homan Avenue to a point 65 feet east thereof, All Days, All Times [02021-1881]
