The existing 2-story mixed use building will be renovated. There are 2 commercial spaces at grade each containing

1,269 square feet ("SF") and 2,674, SF, respectively. The building will be legally converted from 1 dwelling unit to 3 dwelling units.

Further, a 3-story addition will be built at the rear of 3504 N. Elston. This addition will have a height of 46-6" and contain 1 dwelling unit. When complete, there will be 2 commercial spaces, 3 dwelling units and 2 new parking spaces located on-site.
