### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the language underscored, and by deleting the language struck through, as follow:

#### 4-60-022 Restrictions on additional licenses.

(42.344) (42.345)

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

On the west east side of State Street from Haddock Place to Wacker Drive; and on the south side of Wacker Drive from State Street to Wabash Avenue.

*(Omitted text is unaffected by this ordinance)*

On the west side of Michigan Avenue from Madison Street to Monroe Street; and on the north side of Madison Monroe Street from Michigan Avenue to Garland Court

*(Omitted text is unaffected by this ordinance)*

On the west side of State Street from Benton Couch Place to Randolph Street; and on the north side of Randolph Street from State Street to Dearborn Street.

On the east side of Dearborn Street from Randolph Street to Benton Couch Place; and on the south side of Benton Couch Place from Dearborn Street to State Street.

On the west side of State Street from Lake Street to Benton Couch Place; and on the north side of Benton Couch Place from State Street to Dearborn Street.

On the east side of Dearborn Street from Benton Couch Place to Lake Street; and on the south side of Lake Street from Dearborn Street to State Street.

*(Omitted text is unaffected by this ordinance)*

- 347) On the east side of Dearborn Street from Lake Street to Wacker Street Drive; and on the south side of Wacker Drive from Dearborn Street to State Street.
- 348) On the west side of Dearborn Street from Wacker Street Drive to Lake Street; and on the north side of Lake Street from Dearborn Street to Clark Street.

On the east side of Clark Street from Lake Street to Wacker Street Drive; and on the south side of Wacker Street Drive from Clark Street to Dearborn Street.
