RMW STREETERVILLE LLC Acct. No.: 399254 - 2

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RMW STREETERVILLE LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use fifty-eight (58) Window Surround(s) projecting over the public right-of-way adjacent to its premises known as 451 E GRAND AVE.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1533265 herein granted the sum of two thousand two hundred forty-four (\$2,244.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 05/18/2021.
