ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 through 8 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.82), which was previously deleted as shown in the Journal of Proceedings of July 24, 2019 at page 2656, with the following underscored text:

4-60-022 (35.82) On North Milwaukee Avenue, from North Kedzie Avenue to North Kimball Avenue.

SECTION 3. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.1), which was previously deleted as shown in the Journal of Proceedings of November 13, 2019 at page 8965, with the following underscored text:

4-60-023 (35.1) On West Irving Park Road, on the south side only, from North Christiana Avenue to North Bernard Street: and on both sides of West Irving Park Road, from North Bernard Street to North St. Louis Avenue to North Drake Avenue.

SECTION 4. Section 4-60-023 of the Municipal Code of Chicago, is hereby amended by replacing subsections 4-60-023 (35.48) and 4-60-023 (35.55), which were previously deleted as shown in the Journal of Proceedings of January 17, 2018 at page 65183, with the following underscored text:

4-60-023 (35.48) On North Kimball Avenue, from West Addison Street to West Grace Street. 4-60-023 (35.55) On North Kimball Avenue, from West Grace Street to West Addison Street.

SECTION 5. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.73), which was previously deleted as shown in the Journal of Proceedings of November 14, 2018 at page 91289, with the following underscored text:

4-60-023 (35.73) On West Armitage Avenue, from North Karlov Avenue to Kostner Avenue.

SECTION 6. Section 4-60-02 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.83), which was previously deleted as shown in the Journal of Proceedings of November 14, 2018 at page 91290, with the following underscored text:

4-60-023 (35.83) On West Fullerton Avenue, from North Monticello Avenue to North Kimball Avenue.

SECTION 7. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.85), which was previously deleted as shown in the Journal of Proceedings of December 14, 2016 at page 40017, with the following underscored text:

4-60-023 (35.85) On West Armitage Avenue, from North Lowell Avenue to North Kedvale Avenue.

SECTION 8. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.93), which was previously deleted as shown in the Journal of Proceedings of November 14, 2018 at page 91292, with the following underscored text:

4-60-023 (35.93) On the north side of West Lawrence Avenue, from North Central Park Avenue to North Lawndale Avenue, and on both sides of West Lawrence Avenue, from North Lawndale Avenue to North Hamlin Avenue.
