Said Sign structure(s) measures as follows along N. Damen Ave.:

One (1) at sixteen (16) feet in length, two (2)' feet in height and twelve (12) feet above grade level.

One (1) .at three (3) feet in length; three point five (3.5) feet in height and ten point five (1.0.5) feet

above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection; and the Office of the City Clerk.
