Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to W E O'NEIL CONSTRUCTION CO upon the terms and subject to the conditions of this ordinance lo maintain and use two (2) Sign(s) projecting over the public right-of-way attached to its premises known as 1245 W WASHINGTON BLVD.

Said Sign structure(s) measures as follows along W WASHINGTON BLVD:

One (1) at twelve point five eight (12.58) feet in length, one point five (1.5) feet in height and forty-one point five (41.5) feet above grade level.

Said Sign structure(s) measures as follows along N ELIZABETH ST:

One (1) at twelve point five eight (12.58) feet in length, one point five (1.5) feet in height and forty-one point five (41.5) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP 1147739 herein granted the sum of two hundred (\$200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
