BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

West Grace Street; North Cicero Avenue; a line 107.32 feet south of and parallel to West Grace Street; and the alley next west of and parallel to North Cicero Avenue.

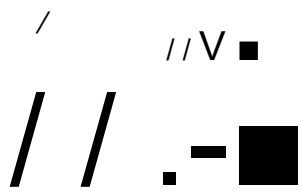
