### ORDINANCES

CULVER'S OF CHICAGO RAVENSWOOD ^AcjLMth:-473047 -3

Permit No: BACP 1560129

*Be it Ordained 'by the City Council of the City of Chicago:*

SECTION 1. Pafmpssien and authority are hereby given and granted to CULVER'S OF CHICAGO RAVENSWOOD upon the ^ terms, and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Park benches on the public right-of-way for beautification purposes adjacent to the premises known as 4300 - 4340 N HONORE ST,

Said Park benches at 4300 measure(s);

Two (2) at six (6) feet in length and three (3) feet in width for a total of thirty-six {36} square feet

The location of said privilege shall be as shown on prints to be on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and any other required provisions of the Municipal Code of Chicago,

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1560129 herein granted the sum of three hundred; two hundred and fifty (\$325,000.00) per annum in advance

A 25% penalty will be added for payments received after due date.

The grantee agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of property caused by the City performing work in the public way.

Authority hereby granted for a period of five (5) years and after 07/28/2021;;
