Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MRR 678 Kingsbury LLC upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Sheeting(s) under the public right-of-way adjacent to its premises known as 676 N KINGSBURY ST.

Said Sheeting(s) at N. Kingbury Street measure(s):

One (1) at six point six seven (6.67) feet in length and Zero (0) feet in width for a total of six point six seven (6.67) square feet.

Said Sheeting(s) at W. Huron Street measure(s):

One (1) at eight point five (8.5) feet in length and Zero (0) feet in width for a total of eight point five (8.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
