ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the 133-2 Community Shopping District and RT4 Residential Two-Flat Townhouse and Multi-Unit District symbols and indications as shown on Map No. 15-1 in the area bounded by

West Devon Avenue; North Whipple Street; a line 239 feet south of and parallel to West Devon Avenue; the alley next west of and parallel to North Whipple Street; the alley next south of and parallel to West Devon Avenue; and a line 157 feet west of and parallel to North Whipple Street;

to those of a B3-2 Community Shopping District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The school building will remain. The addition to the school building will be two stories with a height of around 37'. Also, there will be a religious assembly use located within the existing school building. That use will contain 240 seats.
