Permission end authority ere hereby given and granted to HANA RESTAURANT upon the terms and subject to the conditions of this ordinance to construct, install, maintain end use one (1) Awning with Lettering or GrapWcs(s) projecting over the public rightof-way adjacent to its premises known as 1311 W TAYLOR ST.

Said Awning with Lettering or Graphics<sup>^</sup>) at W. Taykw Street measure<sup>^</sup>): One (1) at fifteen (15) feet in length and two (2) feet in width for a total of thirty (30) square feel

The location of said privilege shall be as shown on prints kept on We with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance wilh plans and specifications approved by ihe Zoning Department • Signs.
