TRAFFIC WARNING SIGN AND/OR SIGNALS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, that the Commissioner of Transportation is hereby authorized and directed to erect and/or amend Traffic Warning Signs and Signals, for the following locations are hereby designated:

- WARD TRAFFIC WARNING SIGNS AND/OR SIGNALS:
- 1 1315-1323 West Ohio Street (south side) from a point 20 feet east of North Ada Street to a point 150 feet east thereof; No Parking Except Authorized School Personnel, 7:30am to 4:30pm, Monday through Friday [02021-3429]
- 24 Repeal Ordinance which reads: South Homan Avenue between West Lexington Street and West Harrison Street; Rush Hour Parking Restrictions [02021-3434]
- 30 West Wellington Avenue from North Austin Avenue to North McVicker Avenue (southside) West George Street from North Austin Avenue to North McVicker Avenue (northside) and North McVicker Avenue from West George Street to West Wellington Avenue (eastside); , 7:00am to 4:30pm, Monday-Friday (School Days) School Personnel Only (excluding Holidays) [Or2021-187]
- 30 North Austin Avenue (east and west sides) from West Fullerton Avenue to West Belmont Avenue; Repeal Rush Hour Parking [02021-3272]
- 40 West Bryn Mawr Avenue and North Hermitage Avenue; All Way Stop, Stopping All Approaches [Or2021-133]
