Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LAKEVIEW SMOKE & VAPE INC. upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning with Lettering or Graphics(s) projecting over the public right-of-way adjacent to its premises known as 3149 N BROADWAY .

Said Awning with Lettering or Graphics(s) at 3149 N BROADWAY measure(s):

One (1) at fourteen (14) feet in length and two (2) feet in width for a total of twenty-eight (28) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1550364 herein granted the sum of fifty (\$50.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

SECTION 1. Permission and authority are hereby given and granted to Raising Cane's Restaurants, LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Exterior mount(s) projecting over the public right-of-way adjacent to its premises known as 3700 N CLARK ST.

Said Exterior mount(s) at N.Clark Street measure(s):

Three (3) at two (2) feet in length and zero point seven five (0.75) feet in width for a total of four point five (4.5) square feet.

Three (3) at four (4) feet in length and two (2) feet in width for a total of twenty-four (24) square feet.
