COMMERCIAL VACATION & DEDICATION ORDINANCE

WHEREAS, the City of Chicago ("City") is a hpnrie rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 2100-2118 S. Sawyer Avenue and 2117-2127 S. Spaulding Avenue are owned by Chicago Title Land Trust as Trustee under Trust Agreement dated Novembers, 2019, and known as Trust 8002382184 ("Developer"); and

WHEREAS, the Developer proposes to use the portion of the alley to be vacated herein for assembling its surrounding lots, and fencing to secure the adjacent property; and '

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subversed is such as to warrant the dedication of a new public alley turn around area and the vacation of a portion of an existing dead-ended public alley, each as described below; now therefore, :

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The Commissioner of the Chicago Department of Transportation (the

"Commissioner"), or any of the Commissioner's designees, is each hereby authorized and directed to approve a dedication of certain property owned by the Developer, for use as public way, as shaded and identified by the words "HEREBY DEDICATED" on the plat hereto attached as Exhibit A, which plat for greater certainty is hereby made a part of this ordinance, and legally described below, as the same is intended for public use and the public interest will be subserved by such dedication:

THE EASTERLY 10 FEET OF LOT 34 IN THE RESUBDIVISION OF BLOCK 21 IN DOUGLAS PARK ADDITION TO CHICAGO, RECORDED JUNE 3, 1889 AS DOCUMENT #1109747 IN THE EAST 1/2 OF THE SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 39 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, SAID ABOVE DESCRIBED PARCEL CONTAINING 250 SQUARE FEET OR 0.006 ACRES, MORE OR LESS.

SECTION 2. That certain right of way portion, as shaded and identified by the words "HEREBY VACATED" on the plat hereto attached as EXHIBIT B and made a part of this ordinance, and legally described below, is hereby vacated and closed, as the same is no longer required for public use and the public interest will be subserved by such vacation:

THAT PART OF A NORTH-SOUTH 16 FOOT AND 21 FOOT WIDE PUBLIC ALLEY; LYING NORTHERLY OF AND ADJOINING CHICAGO, BURLINGTON, AND QUINCY RAILROAD RIGHT-OF-WAY, ALSO LYING EAST OF AND ADJOINING THE EAST LINE OF LOTS 30, 31, 32 AND 33; ALSO LYING SOUTH OF AND ADJOINING A LINE FROM THE NORTHEAST CORNER OF LOT 33 (ALSO BEING THE SOUTHEAST OF LOT 34) EAST TO THE SOUTHWEST CORNER OF LOT 7 (ALSO BEING THE NORTHWEST CORNER OF LOT 8); LYING WEST OF ADJOINING THAT PART OF THE WEST LINE OF LOT 8 AND THE WEST LINE OF VACATED NORTH-SOUTH 5 FOOT WIDE PUBLIC ALLEY AS VACATED BY ORDINANCE AND RECORDED JANUARY 27, 1927, AS DOCUMENT #9534344; ALL IN THE RESUBDIVISION OF BLOCK 21 OF DOUGLAS PARK ADDITION TO CHICAGO AS RECORDED ON JUNE 3, 1889, AS DOCUMENT #1107947, IN THE EAST 1/2 OF THE SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 39 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, SAID ABOVE DESCRIBED PARCEL CONTAINING 1,467 SQUARE FEET OR 0.034 ACRES, MORE OR LESS.

SECTION 3. The City of Chicago hereby reserves for the benefit of Commonwealth Edison, AT&T/SBC, Comcast, and Crowncastle, and each of their successors and assigns, a nonexclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment, and underground conduit, cables, and associated equipment, for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the alley herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of said facilities. No construction, buildings, permanent structures or obstructions shall occur or be placed over the area herein vacated without an express written release of easement by the involved utilities. Any future Developer-prompted relocation of facilities lying within the area being vacated will be accomplished by the involved utilities, and be done at the expense of the Developer, its successors or assigns.

SECTION 4. Although there are no Department of Water Management public water or sewer facilities contained within the areas herein vacated and dedicated, the Developer acknowledges that any private water or sewer services within the dedication area must be permanently terminated, sealed and removed to private property, at the Developer's expense in accordance with the standard procedures and required permitting (on both public and private land) of the Department of Water Management, Sewer Section, including but not limited to the delivery of as-built drawings within 30 days of completion. Further, the Developer acknowledges that it is its responsibility to provide proper drainage on the alley herein dedicated in accordance with plans reviewed, approved and permitted by the Department of Water Management Sewer Design Section, prior to work.

: ■ SECTION 5. ■" The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, the Developer shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said .p-"4 <->f mihlir. allev hereby vacated the appraised sum of

: SECTION 6. The vacation and dedication herein provided for are made under the condition that the Developer and its successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to such vacation and dedication.

SECTION 7. The vacation and dedication; herein provided for are made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed^for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the associated full-sized plats as approved by the Superintendent of Maps and Plats. ; ■ -

SECTION 8. This ordinance shall take effect and be in force from and after its passage and publication. The vacation and dedication shall take effect and be in force from and after the recording of the approved ordinance and the plats.
