### ORDINANCE

Lakeview Medical Campus, LLC Acct. No.: 364898 -1 Permit  
No: BACP 1588596

*Be It Ordained by the City Council of the City of Chicago:*

■ SECTION 1. Permission/and authority are hereby given and granted to Lakeview Medical Campus, LLC ■ upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 1333 W BELMONT AVE. ■

Said Cornice(s) at W. Belmont (east side cornice) measure(s):

One (1) at sixty-nine point eight three (69.83) feet in length and one point three three (1.33) feet in width for a total of ninety-two point eight seven (92.87) square feet.

Said Cornice(s) at W. Belmont (west side cornice) measure(s):

One (1) at one hundred one point four two (101.42) feet in length and one point three three (1.33) feet in width for a total of one hundred thirty-four point eight nine (134.89) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1588596 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with

damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 10/05/2021.
