Be It Ordained by the City Council of the City of Chicago:

SECTION 1. permission and authority are hereby given and granted to CHICAGO LARAMIE CURRENCY EXCHANGE.INC. upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Security Camera(s) projecting over the public right-of-way for security purposes adjacent to its premises known as 5135 W CHICAGO AVE.

Said Security Camera(s) at W. Chicago measure(s):

Four (4) at zero point three three (0.33) feet in length, Zero (0) feet in width and twelve (12) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk. j

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - SignsDepartment of Planning and Development and Department of Transportation (DiviRion of Project Development).

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1148139 herein granted the sum of Zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due data.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. J;
