BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Section 10-20-430 of the Municipal Code of the City of Chicago, Commissioner of Transportation is hereby authorized and directed to exempt 7 Seas Pet Care Center of 13311-13315 S Brandon (Sylvia Ellman- Property Owner) from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for Premise Address.
