*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to 900 BLOCK I HOLDINGS, LLC upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, forty (40) Door Swing(s) on the public right-of-way adjacent to its premises known as 159 N SANGAMON ST.

The grantee' shall pay to the City of Chicago as compensation, for the privilege #BACP1589214 herein granted the sum of three thousand (\$3,000.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
