West Garfield Boulevard; a line 57.44 feet west of and parallel to South Wolcott Avenue; the alley next south of and parallel to West Garfield Boulevard; and a line 87.44 feet west of and parallel to South Wolcott Avenue, ,

*to those of an RM 4.5 Residential Multi-Unit District.*
