ORDINANCE

SOUTH EAST CHICAGO COMMISSION Acct. No.:

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SOUTH EAST CHICAGO COMMISSION upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Trash container(s) on the public right-of-way adjacent to its premises known as 45 E 51 ST ST.

Said Trash container(s) at E. 51st Street measure(s):

One (1) at one (1) feet in length and Zero (0) feet in width for a total of one (1) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination)Department of Streets and Sanitation (Bureau of Sanitation) and Department of Transportation (Division of Project Development)Department of Planning and Development and Department of Transportation (Division of Project Development)Department of Streets and Sanitation (Bureau of Sanitation) and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1590926 herein granted the sum of seventy-five (\$75.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
