BEIT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M2-2 Light Industry District symbols and indications as shown on Map No. 13-H in the area bounded by "

Re: Proposed Industrial Corridor Map Amendment - 5435 N Wolcott Avenue

On June 16, 2022, the Chicago Plan Commission recommended approval of the proposed Industrial Corridor Map Amendment within the Ravenswood Industrial Corridor, submitted by Smylie Brothers Brewing Company, LLC, for the property generally located at 5435 N Wolcott Avenue. The applicant proposes lo rezone the site from M2-2 (Light Industry District) and the Applicani proposes to rezone the site to C3-3 (Commercial, Manufacturing and Employment District) to allow for outdoor patio.
