Permission and authority are hereby given and granted to LAKEVIEW CHAMBER OF COMMERCE upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use seven (7) Park bench(s) on the public right-of-way for beautification purposes adjacent to its premises known as 3100 - 3166 N LINCOLN AVE.

This grant of privilege in the public way shall be subject to the provisions of Election 10-28-015 and all other required provisions of the Municipal Code of Chicago. -

The grantee shall: pay to the City of Chicago as compensation for the privilege #BACP1619350 herein granted the sum of five hundred twenty-five (\$525.00) per annum in advance.

A 25% penalty will beladded for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 04/15/2020.
