ORDINANCE

LAKEVIEW CHAMBER OF COMMERCE Acct. No.; 270704 - 67

Permit No: BACP1619356

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LAKEVIEW CHAMBER OF COMMERCE upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use five (5) Park bench(s) on the public right-of-way for beautification purposes adjacent to its premises known as 3141 - 3167 N LINCOLN AVE.

Said Park bench(s) at 3141-3143 N. Lincoln Avenue measure(s):

One (T) at one (1) feet in length and Zero (0) feet in width for a total of one (1) square feet. Said Park bench(s) at 3161

N. Lincoln Avenue measure(s):

Two (2) at one (1) feet in length and Zero (0) feet in width for a total of two (2) square feet. Said Park bench(s) at 3167 N.

Lincoln Avenue measure(s):

Two (2) at one (1) feet in length and Zero (0) feet in width for a total of two (2) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1619356 herein granted the sum of three hundred seventy-five (\$375.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. ■
