Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GOLUB REALTY SERVICES, LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eight (8) Planter(s) on the public right-of-way for beautification purposes adjacent to its premises known as 1001 S STATE ST.

One (1) at thirty-one (31) feet in length and Zero (0) feet in width for a total of thirty-one (31) square feet. Said Planter(s) at measure

Two (2) at eleven (11) feet in length and Zero (0) feet in width for a total of twenty-two (22) square feet. Said Planter(s) at S. State

Street measure(s):

One (1) at thirty-two (32) feet in length and Zero (0) feet in width for a total of thirty-two (32) square feet. Said Planter(s) at measure(s): Two (2) at eleven (11) feet in length and Zero (0) feet in width for a total of twenty-two (22) square feet. Two (2) at thirty-five (35) feet in length and Zero (0) feet in width for a total of seventy (70) square feet.
