BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Two-Flat, Townhouse and Multi-Unit District and Planned Development Number 1395 symbols and indications as shown on Map No. 10-E in the area bounded by

East 44<sup>th</sup> Street, South Cottage Grove Avenue, East 45<sup>th</sup> Street, and South Evans Avenue,

to those of the B3-2 Community Shopping District.

Plan of Development Statements

- 1. The area delineated herein as Planned Development Number 1395, as amended, ("Planned Development") consists of approximately 216,660 square feet (4.97 acres) of Net Site Area which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Chicago Housing Authority ("CHA") and Bright Star Church of God in Christ ("Bright Star"). - 2. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
- 3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. 
