BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Two-Flat, Townhouse and Multi-Unit District and Planned Development Number 1395 symbols and indications as shown on Map No. 10-E in the area bounded by

East 44th Street, South Cottage Grove Avenue, East 45th Street, and South Evans Avenue,

to those of the B3-2 Community Shopping District.

SECTION 2. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is

hereby amended by changing all of the B3-2 Community Shopping District symbols and

Plan of Development Statements

- 1. The area delineated herein as Planned Development Number 1395, as amended, ("Planned Development") consists of approximately 216,660 square feet (4.97 acres) of Net Site Area which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Chicago Housing Authority ("CHA") and Bright Star Church of God in Christ ("Bright Star"). CHA and Bright Star have given consent to the Applicant, 45th/Cottage, LLC, an Illinois limited liability company, to fde this application.
- 2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
- 3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assign or grantees.

- 6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.

The Property is located in a "low-moderate income area" within the meaning of the ARO; the project has a total of 155 units; and the project will receive TIF funds from the City. 
