TRAFFIC LANE - TOW ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD **TOW ZONES:** 3 South Michigan Avenue (East arid West sides) from East Cermak Road to East 23rd Street; No Parking Tow Zone 10:00pm-6:00am, Thursday through Sunday [O2021-4104) 35 4500-4560 North Hamlin Avenue (west side), 3801-3831 West Wilson Avenue (south side), 4501-4559 North Avers Avenue (east side); No Parking Tow Zone Except for Official School Personnel Parking Only 7am -4:30pm (School Days) [02021-5285] North California Avenue; West from West Winnerriac Avenue to West Carmen 40 Avenue, West Carmen Avenue, All Times, All Days [Or2021-242] 42 North Dearborn Street (east side) from a point 20 feet north of West Hubbard Street to a point 85 feet North thereof; No Parking Tow Zone, All Times, All Days [02021-4810] East Upper Wacker Drive (north side) from North Field Boulevard to a point 300 feet 42

west thereof; No Parking Tow Zone, 11:00pni to 8:00am, All Days [02021-4812]
