BE IT ORDA INED BY THE CITY COUNCIL OF THE CITY OF CHIC A GO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 7-N in the area bounded by

A line 100 feet south of and parallel to West George Street; North Sayre Avenue; a line 150 feet south of and parallel to West George Street; and the alley next west of and parallel to North Sayre Avenue,

To those of a RS3, Residential Single - Unit (Detached House)

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


