BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 2-M in the area bounded by:

A line 260 feet south of and parallel to West Madison Street; South Waller Avenue; a line 310 feet south of and parallel to West Madison Street; and the alley next west of and parallel to South Waller Avenue.

To those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District


