# TO THE HONORABLE, THE CI TY COUNCIL OF THE CITY OF CHICAGO

Ladies and Gentlemen:

At the request of the Commissioner of Housing, I transmit herewith an ordinance authorizing the transfer of a project and associated property from Community Housing Partner III LP to RAHF V/5T Englewood LLC.

Your favorable consideration of this ordinance will be appreciated.

#### ORDINANCE j

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters that pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing for persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City, pursuant to Title I of the Housing and Community Development Act of 1974, as amended, supplemented and restated (42 U.S.C. Section 5301 et seq.) (the "Act"), received an allocation of Community Development Block Grant funds ("CDBG Funds") from the United States Department of Housing and Urban Development and allocated the CDBG Funds to certain activities described in the Act as eligible activities, with the primary objective of developing viable urban communities, providing decent housing and a suitable living environment, and expanding economic opportunities principally for persons of low and moderate income; and

WHEREAS, the City programmed certain funds available from a variety of funding sources including CDBG Funds (the "Multi-Family Program Funds") to make loans and grants to owners of rental properties containing five (5) or more dwelling units located in low and moderate income areas for the development of multi-family residential housing, and such Multi-Family Program Funds are administered by the City's Department of Housing ("DOH"); and

WHEREAS, on February 7, 1996, the City Council of the City authorized the making of a loan of Multi-Family Program Funds to Community Housing Partners III L.P., an Illinois limited partnership (the "Borrower") in the principal amount of \$4,415,286, with an interest rate of zero percent per annum and a term not to exceed 32 years (the "Loan"); and

WHEREAS, on or about April 16, 1996, the City made the Loan to the Borrower; and

WHEREAS, the Loan (i) was evidenced by, among other things, that certain Housing Loan Agreement executed by the Borrower on April 16, 1996 (the "Loan Agreement"), and that certain Note dated April 16, 1996 and made by the Borrower in favor of the City in the original principal amount of the Loan (the "Note"), (ii) was secured by, among other things, that certain Junior Mortgage, Security Agreement and Financing Statement dated April 16, 1996 and made by the Borrower in favor of the City (the "Mortgage"), and (iii) was further supported by that certain Regulatory Agreement executed by the Borrower on April 16, 1996 (the "Regulatory Agreement", and together with the Loan Agreement, Note and Mortgage, the "City Loan Documents"); and

WHEREAS, proceeds of the Loan were used for the acquisition, construction and rehabilitation by the Borrower of (1) a multi-family residential development comprising 167 units in 12 separate buildings located generally at 6545 South Normal Avenue; 6547-49 South Normal Avenue; 6553-59 South Normal Avenue/434-42 West 66th Street; 6642-56 South Stewart Avenue/408-10 West 67th Street; 6757-59 South Parnell Avenue; 6850 South Normal Avenue; 7001-03 South Normal Avenue/451-53 West 70th Street; 7000-04 South Eggleston Avenue/443-45 West 70th Street; 7056-58 South Eggleston Avenue/440-42 West 71st Street; 6816-18 South Perry Avenue; 7011-13 South Perry Avenue; 7150 South Eggleston Avenue/436-44 West 72nd Street, and (2) seven (7) parking lots located generally at 7008 South Eggleston Avenue; 6632 South Stewart Avenue; 7049-53 South Eggleston Avenue; 7149 South Eggleston Avenue; 7151

South Eggleston Avenue; 6535 South Normal Avenue and 6858 South Normal Avenue (the "Property"), which Property is commonly known as "Englewood Gardens"; and

WHEREAS, the sole general partner of the Borrower is Chicago Community Development Corporation, an Illinois corporation; and

WHEREAS, pursuant to an ordinance approved by the City Council on June 5, 2013, the Borrower entered into a restructuring on or about December 30, 2013, which (i) altered the maturity and principal payment terms of the Loan, and (ii) caused the subordination of the lien of the Mortgage to the lien of the Senior Loan (as defined below) (the "First Restructuring"); and

WHEREAS, pursuant to the First Restructuring, the Mortgage is subordinate to that certain mortgage dated December 30, 2013, securing a loan in the amount of \$4,335,000 made by the Borrower in favor of Prudential Affordable Mortgage Company, LLC, which includes credit enhancement by Federal Home Loan Mortgage Corporation (the "Senior Loan"); and

WHEREAS, the Borrower desires to transfer the Property and its rights, duties and obligations under the City Loan Documents to RAHF V/5T Englewood, LLC, an Delaware limited liability company (the "Replacement Borrower") or to another entity that is acceptable to the City's Commissioner of Housing (the "Commissioned); and

WHEREAS, the Replacement Borrower desires to finance the acquisition and rehabilitation of the Property by assuming all existing debt in connection with the Property, including the Loan and the Senior Loan, and has requested that the City approve a proposed restructuring, assignment and assumption of the Loan and the City Loan Documents; and

WHEREAS, the DOH desires to approve a restructuring (the "Second Restructuring") of the Loan and the City Loan Documents in a manner that (1) will not alter the principal balance of the Loan; (2) may alter the interest rate on the principal balance of the Loan; (3) may extend the maturity date of the Loan; (4) will not alter the lien position of the Loan; (5) will extend the affordability restrictions imposed by the City Loan Documents for a period of no less than 20 additional years; (6) may consent to the replacement of the current property management agent; (7) will consent to the sale and transfer of the Property to the Replacement Borrower; (8) will consent to the assignment and assumption of the City Loan Documents from the Borrower to the Replacement Borrower; and (9) will release the Borrower from its rights, duties and obligations under the City Loan Documents (collectively, the "Material Terms"); now, therefore,

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Second Restructuring is hereby approved as described above. The Commissioner or a designee of the Commissioner (each, an "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Second Restructuring. Each Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and perform any and all acts as shall be necessary or advisable in connection with the Corporation Counsel, to enter into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan that does not substantially modify the Material Terms.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Restructuring (collectively, the "Owner"), any

legal entities which are direct or indirect owners in excess of 7.5% of the Owner which changed in connection with the Restructuring, and all legal entities who constitute the direct or indirect controlling parties of the Owner (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Second Restructuring.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
