#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, ofthe Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 8-F in the area bounded by

A line 31.85 feet north of and parallel to West 32<sup>nd</sup> Street; the alley next east of and parallel to South Union Avenue; a line 56.85 fect north of and parallel to West 32<sup>nd</sup> Street; South Union Avenue

to those of RT-4 Residential Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.




