Amendment of ordinance for honorary street name designation for Mary Delores Espinosa-Matos Honorary Way which reads:

"Section 1. Pursuant to Section 2-8-040 of the Municipal Code of Chicago, Which allows erection of honorary street name designations, the Commissioner of the Chicago Department of Transportation shall take the necessary action for the standardization of S Racine Ave from 19<sup>th</sup> Street to 1844 S Racine Ave as "MARY DELORES ESPINOSA-MATOS HONORARY WAY" Section 2. This ordinance shall take effect upon its passage and publication."
