BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

The public alley next north of and parallel to West Superior Street; a line 102.75 feet west of and parallel to North Paulina Street; West Superior Street; and a line 127.75 feet west of and parallel to North Paulina Street.

to those of a RT 4 Residential Two-Flat. Townhouse and Multi-Unit District.
