

A line 37.44 feet east of and parallel to North Leavitt Street; a line 94.55 feet north of and parallel to West Eastwood Avenue; a line 74.88 feet east of and parallel to North Leavitt Street; And West Eastwood Avenue,

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about APRIL 27,2022,1, the applicant,. LORI A ORZECHOWSKI, will file an application for a change in zoning from RS-3 TO RT-4 for the property located at 2176 W. EASTWOOD AVE., CHICAGO, IL 60625.

Currently, the owner will seek to legalize and convert from 2 dwelling units to 3 dwelling units: a residential unit on the 1st floor, a residential unit on the 2nd floor, and a residential unit on the 3rd floor.

I intend to renovate the building and add a dormer on the 3rd floor so that the stair to the 3rd ' floor will comply with the building code.
