A line 75.0 feet north of and parallel to West Cullerton Street; the public alley next east of and parallel to South Jefferson Street; a line 25.0 feet south of and parallel to West Cullerton Street; and South Jefferson Street

to those of an B2-3, Neighborhood Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
