WHEREAS, On July 20, 2022, Alderman Brendan Reilly and Alderman Scott Waguespack, as co-chairs, established the Chicago City Council Taiwan Friendship' Caucus; and

WHEREAS, The Chicago City Council Taiwan Friendship Caucus is initiated during the tenure of Johnson Chiang, director general of Taiwan's Taipei Economic and Cultural Office in Chicago; and

WHEREAS, The Chicago City Council will be the first City Council in the U.S. Midwest to establish a Taiwan Friendship Caucus, and the caucus has bipartisan and multi-caucus support; and

WHEREAS, Taiwan shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the United States and the City of Chicago; and

WHEREAS, The Chicago City Council Taiwan Friendship Caucus will further the bilateral relationship with Taiwan and will continue to affirm and support Taiwan's meaningful participation in international organizations; and

WHEREAS, The Chicago City Council Taiwan Friendship Caucus reaffirms the commitment to strengthening and deepening the cordial ties between the City of Chicago and Taiwan; now therefore,

BE IT RESOLVED, That we, the Mayor and members of the City Council of the City of Chicago, gathered here this twentieth day of July, 2022, commemorate the formation of the Chicago City Council Taiwan Friendship Caucus; and BRENDAN REILLY Alderman, 42^{ricl} Ward
