# Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the Bl-2 Neighborhood Shopping Zoning District symbols and indications as shown on Map No. 11-H in the area bounded by

A line 45 feet southeasterly of West Berteau Avenue as measured along the southwest line of North Lincoln Avenue and perpendicular thereto; North Lincoln Avenue; a line 70 feet southeasterly of West Berteau Avenue as measured along the southwest line of North Lincoln Avenue and perpendicular thereto; and the alley next southwest of North Lincoln Avenue.

to those of a CI-2 Neighborhood Commercial Zoning District.

SECTION 2. This ordinance be in force and effect from and after its passage and due publication.
