**SECTION 1.** Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, that the Commissioner of Transportation is hereby authorized and directed to erect and/or amend Traffic Warning Signs and Signals, for the following locations are hereby designated:

#### WARD TRAFFIC WARNING SIGNS AND/OR SIGNALS:

- 3 South Shields Avenue from West 43rd Street to West 44th Place; No Truck Over 5 Tons 22-00966087[O2022-1751]
- 22 South Kedvale Avenue and West 24th Place; Three Way Stop, Stopping All Approaches {02021-5260}
- 22 South Millard Avenue and West 32nd Street; Three Way Stop Sign Stopping All Approaches {02021-5676}
- 22 West 32nd Street and South Springfield Avenue; All Way Stop Sign, Stopping All Approaches {02021-5677}
- 39 North Cicero Avenue (eastside), from North Forest Glen Avenue To West Peterson Avenue Also Add, North Cicero Avenue, (west side), From North Caldwell Avenue South Leg to North Caldwell Avenue North Leg; No Parking Of Semi-Trucks Tow Zone (Public) 22-00965584 [O2022-1739]
