SUBSTITUTE ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by deleting the language struck through, as follows:

4-60-023 Restrictions on additional licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

(30.73) ~~On North Milwaukee Avonuo, from North Central Park Avonuo to North~~

~~Monticello Avenue, and on the northeast side of North Milwaukee Avenue, from North Monticello Avenue to North Ridgeway Avenue, and on the east side of North Ridgeway Avenue, from North Milwaukee Avenue to West Belmont Avenue.~~
