SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 15-G in the area bounded by

A line 100 feet north of and parallel to West Thorndale Avenue; North Sheridan Road; West Thorndale Avenue; and a line 150.07 feet west of parallel to North Sheridan Road,

to those of a B3-2 Community Shopping District
