ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters that pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing for persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City, pursuant to the HOME Investment Partnerships Program ("HOME Program"), received from the United States Department of Housing and Urban Development an allocation of funds ("HOME Funds") to make loans and grants to expand the long-term supply of affordable housing through, among other things, acquisition, new construction, reconstruction and moderate and substantial rehabilitation in low- and moderate-income areas; and

WHEREAS, pursuant to a Loan Agreement dated September 1, 2003 ("Loan Agreement"), the City made a loan of HOME Funds in the principal amount of \$7,992,100, with an interest rate of one percent per annum and a term not to exceed forty-two years (the "Loan"), to South Park Plaza, L.P., an Illinois limited partnership (the "Original Borrower"); and

WHEREAS, the Loan was evidenced by, among other things, that certain Note dated as of September 1, 2003 made by the Original Borrower in favor of the City in the original principal amount of the Loan (the "Note"), and was secured by, among other things, that certain Junior Mortgage, Security Agreement and Financing Statement dated as of September 1, 2003 made by the Original Borrower in favor of the City (the "Mortgage"), and was further supported by that certain Regulatory Agreement executed by the Original Borrower on September 1, 2003 (the "Regulatory Agreement", and together with the Loan Agreement, Note and Mortgage, the "City Loan Documents"); and

WHEREAS, proceeds of the Loan were used to provide for the acquisition, construction and equipping by the Original Borrower of six buildings with 134 residential multi-family units, located generally at 2601 South Prairie Avenue, 2600 South Dr. Martin Luther King, Jr. Drive, 2610-18 South Calumet Avenue, 2619-35 South Calumet Avenue, 2625-41 South Prairie Avenue, and 2622-30 South Dr. Martin Luther King, Jr. Drive, Chicago, Illinois 60616 (the "Property"); and

WHEREAS, the sole general partner of the Original Borrower is South Park Plaza, Inc. an Illinois not-for-profit corporation; and

WHEREAS, the Mortgage is subordinate to that certain Mortgage dated as of September 1, 2003 and made by the Original Borrower in favor of Midland Loan Services, Inc., a Delaware corporation (the "Senior Lender"), securing a loan in the amount of \$8,800,000 (the "Senior Loan"); and

WHEREAS, the Original Borrower desires to transfer the Property and its rights, duties and obligations under the City Loan Documents to South Park Preservation, LP, an Illinois limited partnership ("Replacement Borrower") or to another entity that is acceptable to the Commissioner of DOH (as defined below); and

WHEREAS, the general partner of the Replacement Borrower is South Park Plaza GP, LLC, an Illinois

limited liability company, the members of which are Full Circle Communities, Inc., an Illinois not-for-profit corporation and BAHC Development, LLC, an Illinois limited liability company; and

WHEREAS, the Replacement Borrower desires to finance the acquisition and rehabilitation of the Property by executing a new mortgage in connection with the Property in favor of Illinois Housing Development Authority, or with any other financial institution that is acceptable to the Commissioner of DOH (the "New First Mortgage"), and has requested that the City approve a proposed restructuring and assignment of the Loan and the City Loan Documents; and

WHEREAS, the City's Department of Housing ("DOH") desires to approve a restructuring (the "Restructuring") of the Loan and the City Loan Documents in a manner that (1) will decrease the principal balance of the Loan and allow partial repayment of interest on the Loan, (2) may alter the interest rate on the principal balance of the Loan, (3) may extend the maturity date of the Loan, (4) will subordinate the lien of the Mortgage to the lien of the New First Mortgage, (5) will consent to the sale and transfer of the Property to the Replacement Borrower, (6) will consent to the assignment of the City Loan Documents by the Original Borrower to the Replacement Borrower, (7) will release the Original Borrower from its rights, duties and obligations under the City Loan Documents, and (8) will amend the Regulatory Agreement and extend the affordability requirements therein for an additional 30 years (collectively, the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner of DOH or a designee of the Commissioner of DOH (each, an "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Restructuring. Each Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan that does not substantially modify the Material Terms.


SECTION 3. The Authorized Officer is hereby authorized, subject to the approval by the Corporation Counsel, (a) to enter into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with the assignment ofthe Loan, as restructured in accordance with the Restructuring, to the Replacement Borrower, and (b) to consent to the transfer of the Property from the Original Borrower to the Replacement Borrower.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of

this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any ofthe other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
