ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the PMD 8A Planned Manufacturing District symbols and indications as shown on Map No. 10-F in the area bounded by:

A line 693.00 feet south of and parallel to West Pershing Road; South Princeton Avenue; a line 1,221.00 feet south of and parallel to West Pershing Road; a line 51.23 feet west of and parallel to South Princeton Avenue and South Princeton Avenue; a line 1,536.92 south of and parallel to West Pershing Road; a line 104.39 feet west of and parallel to South Princeton Avenue; a line 1, 221.00 feet south of and parallel to West Pershing Road; a line 159.31 feet west of and parallel to South Princeton Avenue; a line 1,029.40 feet south of and parallel to West Pershing Road; a line 273.16 feet west of and parallel to South Princeton Avenue; a line 1,474.48 feet south of and parallel to West Pershing Road; a line 563.66 west of and parallel to South Princeton Avenue; West Root Street; a line 737.14 feet west of and parallel to South Princeton Avenue

to those of a Planned Development which is established in the area described above.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

PLANNED DEVELOPMENT NARRATIVE STATEMENT 328 W. 40th PLACE

The Applicant, TMG AD, LLC (f/k/a TMG Acquisition Disposition I, LLC), an affiliate of The Missner Group, is the contract purchaser for the property commonly known as 328 W. 40th Place ("Subject Property"). The Subject Property currently contains an industrial and manufacturing facility, which closed several years ago, consisting of 10 different obsolete, dilapidated, and vacant buildings on approximately 12.42 acres of land generally located at the northwest corner of West Root Street and South Princeton Avenue. Railroad tracks abut the north and west boundaries of the Subject Property.

The Subject Property is currently zoned PMD 8A. Because the Subject Property is in excess of 10 acres, Applicant seeks Planned Development approval of the project as required by Section 17-9-0117-F of the Chicago Zoning Ordinance.

Surrounding property directly to the north and west are also zoned PMD 8A with a few parcels to the west zoned Ml-2 and M2-3. The property to the east across Princeton Avenue is predominately zoned M2-3 with a small area zoned POS-2. Property to the southeast across Root Street is zoned Cl-2. Directly to the south across Root Street is zoned PD 54 and to the southwest across Root Street is zoned Ml-2. Property to the

northwest of the Subject Property is zoned M2-3 and northeast of the Subject Property is zoned RT-4. The uses in the vicinity of the Subject Property are almost entirely industrial/manufacturing with a limited amount of residential to the south and northeast. The uses in the surrounding area have coexisted for decades.

The Applicant proposes to demolish the existing buildings and develop an approximately 180,900. square foot, state-of-the-art, industrial warehouse and distribution building, with approximately 9,000 square feet of modern office space. The proposed new building will be constructed with architectural pre-cast wall panels and have an exterior height of 44 feet. The project will include approximately 35 truck loading docks, 38 semi-truck and trailer parking stalls, and 176 automobile parking stalls and will be designed to meet the requirements of the Chicago Landscape Ordinance. The development is designed with detention ponds in the southwest and southeast corners of the Subject Property. Automobile only access will be from West Root Street at the southwest corner of the site. Semi-truck and trailer access will be from South Princeton Avenue at the northeast corner of the Subject Property.

PLANNED DEVELOPMENT STATEMENTS

- 1. The area delineated herein as Planned Development Number , (Planned Development) consists of approximately [543,226 square feet] of property which is depicted on the attached Planned Development Boundary and Property Line Map (Property) and is owned or controlled by the Applicant, TMG AD, LLC, an Illinois limited liability company.
- 2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400-of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400.
- 3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Planned Development.

Ingress or egress shall be pursuant to the Planned Development and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

Pursuant to a negotiated and executed Perimeter Restoration Agreement ("Agreement") by and between the Department of Transportation's Division of Infrastructure Management and the Applicant, the Applicant shall provide improvements and restoration of all public way adjacent to the property, which may include, but not be limited to, the following as shall be reviewed and determined by the Department of Transportation's Division of Infrastructure Management:

- Full width pf streets
- Full width of alleys
- Curb and gutter
- Pavement markings
- Sidewalks
- ADA crosswalk ramps
- Parkway & landscaping

The Perimeter Restoration Agreement must be executed prior to any Department of Transportation and Planned Development Part II review permitting. The Agreement shall reflect that all work must comply with current Rules and Regulations and must be designed and constructed in accordance with the Department of Transportation's Construction Standards for work in the Public Way and in compliance with the Municipal Code of Chicago Chapter 10-20. Design of said improvements should follow the Department of Transportation's Rules and Regulations for Construction in the Public Way as well as The Street and Site Plan Design Guidelines. Any variation in scope or design of public way improvements and restoration must be approved by the Department of Transportation.

4. This Plan of Development consists of [16] Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; an Aerial Map with Planned Development Boundary, Site Plan; Floor Plans (typical); Landscape Plan; [a Green Roof Plan]; and, Building Elevations (North, South, East and West) prepared by Ware Malcomb and dated (date of Plan Commission presentation), submitted herein. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Planning and Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Chicago Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Chicago Zoning Ordinance, this Planned Development shall control.

- 5. The following uses are permitted in the area delineated herein as a Planned Development: [those uses permitted under PMD 8A].
- 6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
- 7. For purposes of height measurement, the definitions in the Chicago Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
- 8. The maximum permitted floor area ratio (FAR) for the Property shall be in accordance with the attached Bulk Regulations and Data Table. For the purpose of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations and Data Table has been determined using a net site area of [543,226 square feet] and a base FAR of [0.33].
- 9. Upon review and determination, Part II Review, pursuant to Section 17-13-0610, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.

- 10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines, including Section 17-13-0800. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
- 11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-085, or any other provision of the Municipal Code of Chicago.
- 12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Section 17-13-061 l-A, by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
- 13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
- 14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The Applicant shall obtain the number of points necessary to meet the requirements of the Chicago Sustainable Development Policy, in effect at the time the Part II review


process is initiated for each improvement that is subject to the aforementioned Policy and must provide documentation verifying compliance.

15. The Applicant acknowledges that it is the policy of the City to maximize opportunities for Minority and Women-owned Business Enterprises ("M/WBEs") and city residents to compete for contracts and jobs on construction projects approved through the planned development process. To assist the city in promoting and tracking such M/WBE and city resident participation, an applicant for planned development approval shall provide information at three points in the city approval process. First, the applicant must submit to DPD, as part of its application for planned development approval, an M/WBE Participation Proposal. The M/WBE Participation Proposal must identify the applicant's goals for participation of certified M/WBE firms in the design, engineering and construction of the project, and of city residents in the construction work. The city encourages goals of (i) 26% MBE and 6% WBE participation (measured against the total construction budget for the project or any phase thereof), and (ii) 50% city resident hiring (measured against the total construction work hours for the project or any phase thereof). The M/WBE Participation Proposal must include a description of the Applicant's proposed outreach plan designed to

inform M/WBEs and city residents of job and contracting opportunities. Second, at the time of the Applicant's submission for Part II permit review for the project or any phase thereof, the Applicant must submit to DPD (a) updates (if any) to the Applicant's preliminary outreach plan, (b) a description of the Applicant's outreach efforts and evidence of such outreach, including, without limitation, copies of certified letters to M/WBE contractor associations and the ward office of the alderman in which the project is located and receipts thereof; (c) responses to the Applicant's outreach efforts, and (d) updates (if any) to the applicant's M/WBE and city resident participation goals. Third, prior to issuance of a Certificate of Occupancy for the project or any phase thereof, the Applicant must provide DPD with the actual level of M/WBE and city resident participation in the project or any phase thereof, and evidence of such participation. In addition to the forgoing, DPD may request such additional information as the department determines may be necessary or useful in evaluating the extent to which M/WBEs and city residents are informed of and utilized in planned development projects. All such information will be provided in a form acceptable to the Zoning Administrator. DPD will report the data it collects regarding projected and actual employment of M/WBEs and city residents in planned development projects twice yearly to the Chicago Plan Commission and annually to the Chicago City Council and the Mayor.

16. This Planned Development shall be governed by Section 17-13-0612. Should this Planned Development ordinance lapse, the Zoning Administrator shall initiate a Zoning Map Amendment to rezone the property to (underlying zoning that formed the basis of this Planned Development).






