### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. Design of said improvements should follow CDOT's Rules and Regulations for Construction in the Public Way as well as The Street and Site Plan Design Guidelines. Any variation in scope or design of public way improvements and restoration must be approved by CDOT.

4. This Plan of Development consists of these 17 Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map (two sheets); a Right of Way Adjustment map (two sheets); Site Plan (nine sheets); Landscape Plan (six sheets) prepared by SpaceCo and dated November 14, 2022; and Building 1 Building Elevations (North, South, East and West), Building 2 Building Elevations (North, South, East and West), north, South, East and West) prepared by Cornerstone Architects Ltd.
