ORDINANCE

TT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago - the Chicago Zoning

Ordinance, be amended by changing all the B3-I Community Shopping District symbols and indications as shown on Map No. 7-M in the area bounded by

West Diversey Avenue; North Meade Avenue; the alley next south of and parallel to West Diversey Avenue; and a line 57.36 feet west of and parallel to North Meade Avenue,

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

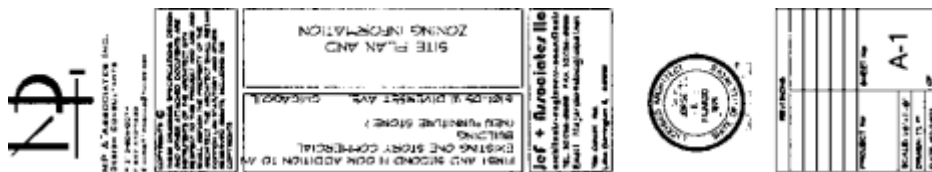

Proposed Land Use: The Applicant is seeking a Zoning Map Amendment in order to permit the renovation and physical expansion of the existing one-story building, at the subject site. The proposed programming for the renovation calls for the erection of a one-story vertical addition above the existing one-story building, as well as the construction of a new two-story addition off the rear of the same existing building, resulting in one unified two-story commercial building.
