WHEREAS, Hank cherished spending time with his family, loved the White Sox and Blackhawks, and

frequently attended games with family, friends and colleagues; and

WHEREAS, He greatly enjoyed spending time outside on the golf course or at the driving range working on his game; and

WHEREAS, His true passion was making people happy, always quick to tell a funny story and offering help whenever he could; and

WHEREAS, To his beloved family, Hank imparts a legacy of generosity, compassion, devotion to family and unwavering faith in God; now, therefore
