WHEREAS, John served as President of the Illinois Trial Lawyers Association as well as Chairman of numerous courtappointed committees representing asbestos victims; and

WHEREAS, At the University of Chicago Medical Center, he served on the Board of Trustees for a number of years, and his expansive philanthropy has quietly supplied support to hundreds of charitable initiatives; and

WHEREAS, John was universally recognized by attorneys and judges around the country as a man of integrity, decency, and honor; and
